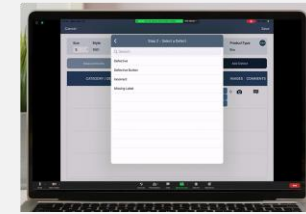
Quality Managers plan QA Activity based on POs/SOs

- Data and intel to analyze vendor performance over time, against products, styles and orders

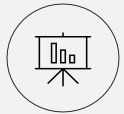

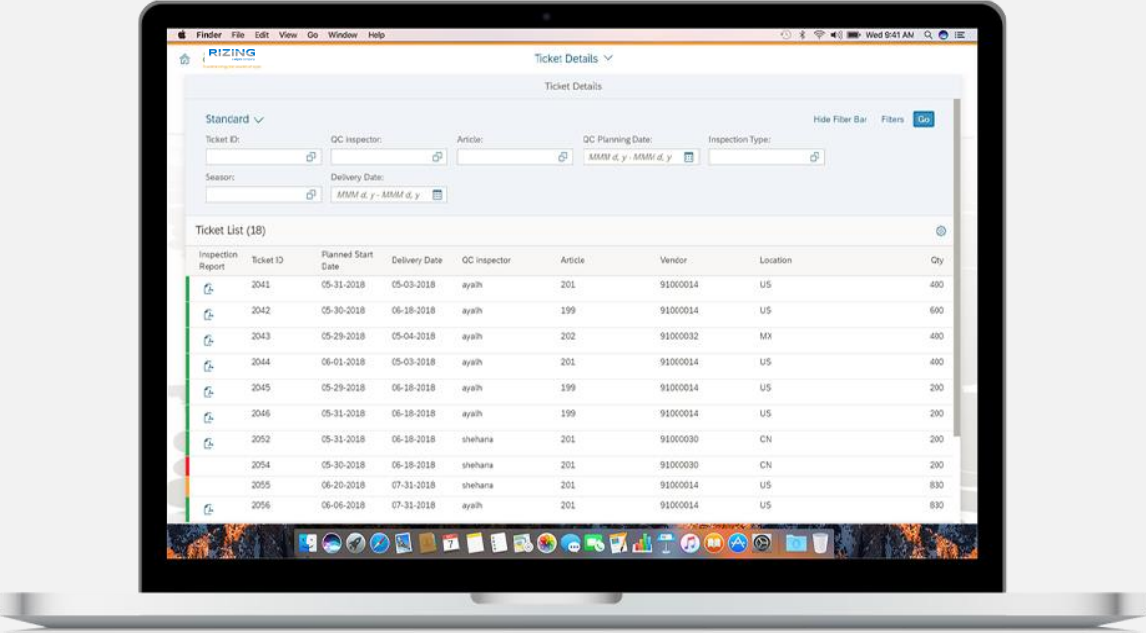

Inspector's Tablet App Dashboard



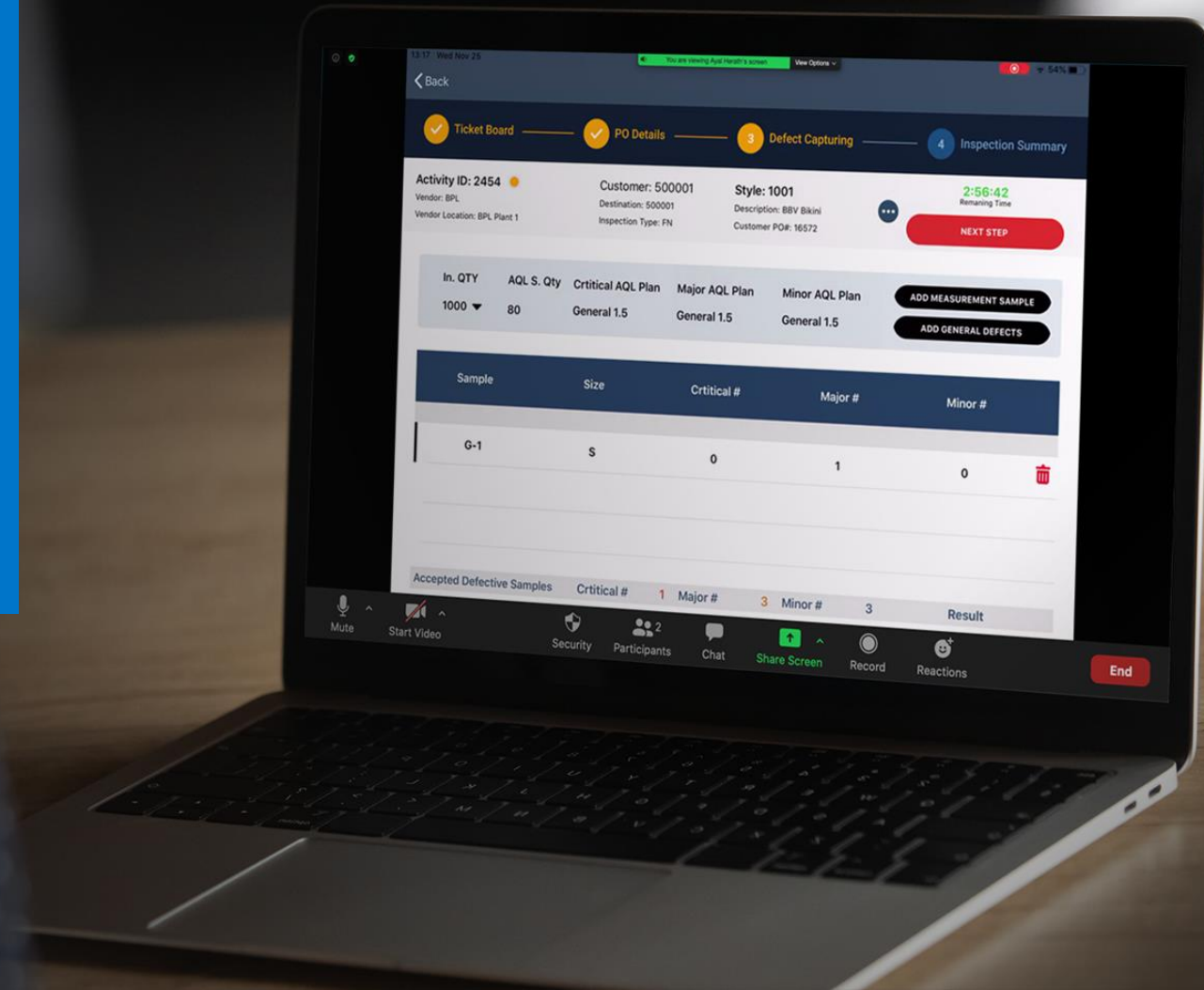
